Indigo Sky Changes Name to Gatekeeper Systems Inc. Announces AGM Results

Abbotsford, BC May 30, 2013 Gatekeeper Systems Inc. (formerly Indigo Sky Capital Corp.) ('Gatekeeper' or the 'Company') (TSX.V:GSI) is pleased to announce that the shareholders' of the Company and the TSX Venture Exchange have approved the Company's name change to 'Gatekeeper Systems Inc.'. Effective at the opening of trading on May 31, 2013, the common shares of Gatekeeper Systems Inc. (formerly Indigo Sky Capital Corp.) will commence trading on the TSX Venture Exchange under the name 'Gatekeeper Systems Inc.' and under the new symbol 'GSI' (formerly 'IDS') and be classified as a manufacturing company.

In addition to the shareholder resolution passed above, the following additional items were approved by the shareholders at the Company's Annual General Meeting held on May 28, 2013:

- Setting the number of directors of the Company at four;
- The election of Douglas A. Dymont, Gary G. Cope, Jonathan Jackson and Beverly Bartlett as directors of the Company for the ensuing year;
- The re-adoption and re-approval of the company's rolling stock option plan in accordance with the requirements of the TSX Venture Exchange;
- The appointment of James Stafford Chartered Accountants as auditor of the Company for the ensuing year;
- The amendment to the Company's Articles to create an unlimited number of Class A Preferred Shares in the capital of the Company; and
- The amendment of the Company's Articles to include advance notice provisions for the nomination of persons for election as directors of the Company.
