Gatekeeper Introduces a Fully Integrated Cloud Software Application for Traffic Infraction Management (TIM™)

Abbotsford, BC August 28th, 2013 - Gatekeeper Systems Inc. (“Gatekeeper” or the “Company”) (TSX.V: GSI) is pleased to announce the introduction of its traffic infraction management system (trade named TIM™). TIM™ software provides stakeholders (such as judicial systems, law enforcement, school districts, and the general public), with a structured system to manage the life cycle of a stop arm violation in an easy to use cloud based software application.

Video evidence of a stop arm infraction is uploaded to TIM™ allowing local law enforcement to review the evidence to determine if it is sufficient to proceed to ticketing. If there is sufficient evidence, a ticket is generated and mailed to the registered owner of the vehicle. The registered owner of the vehicle can then view the video evidence online, using an Internet connection and browser, and choose to either pay the ticket or request a court date.

Doug Dymont, President and CEO of Gatekeeper, stated, “Our cloud based multi-application software platform is an example of how Gatekeeper is driving innovation in our industry. We wanted a total solution for providing safety in and around school buses while having an open architecture to expand into other markets. Our infrared license plate reader, combined with our traffic infraction management software, gives school districts and Counties an end-to-end solution from license plate capture to automating the entire ticketing process. With independent studies of over 15 million stop arm violations in the United States, and average tickets of \$250.00, Gatekeeper’s technology is well positioned to execute on its business model in this growing market.” Dymont also added, “While protecting children is in our corporate DNA, our cloud based software application, combined with our license plate reading sensors, is applicable to many markets. We will be exploring new partnerships to expand our sales reach with this new capability”.
