### **Gatekeeper Announces Completion of Listing in the U.S. with OTC Markets and S&P Capital Coverage**

**Abbotsford, BC, June 5<sup>th</sup>, 2015 - Gatekeeper Systems Inc. (“Gatekeeper” or the “Company”) (TSX.V: GSI; OTC: GKPRF)** is pleased to announce that the Company has completed its listing process in the United States on the OTC Markets, and is currently trading under the symbol “GKPRF”. In connection with the United States listing, the Company has secured DTC eligibility by The Depository Trust Company for its shares, as well as completed publication via S&P Capital IQ Corporations Records Listing Program.

As part of the S&P Capital program, a full description of the Company has been published in the Daily News Section of Standard & Poors’s Corporation Records, a recognized securities manual for secondary trading in up to 38 States under the Blue Sky Laws. S&P Capital IQ Corporation Records is available in print, CD-ROM, and via the web at [www.netadvantage.standardandpoors.com](http://www.netadvantage.standardandpoors.com) as well as through numerous electronic vendors.

The information available through this program includes an in-depth description of Gatekeeper’s business operations, share price, dividend history, shares outstanding, company financial position, earnings, and full income statement and balance sheet.

The Depository Trust Company (“DTC”) is a subsidiary of the Depository Trust & Clearing Corporation DTCC, and manages the electronic clearing and settlement of publicly traded companies. Securities that are eligible to be electronically cleared and settled through the DTC are considered ‘DTC eligible’. This electronic method of clearing securities speeds up the receipt of stock and cash, and thus accelerates the settlement process for investors.

Doug Dymont, President and CEO commented, “We are very pleased to have our common shares trading in the U.S., and to have received the related DTC approval and S&P coverage. Given that the majority of our business is within the United States, we expect that the U.S. listing will enhance trading efficiency of our shares, lower transaction costs, and provide additional value to our current and prospective shareholders. These initiatives will greatly simplify the process of trading our common shares in the United States.”
