### Gatekeeper Appoints Gordon Clissold as CFO

Pursuant to Mr. Clissold’s appointment, the Company has granted 250,000 incentive stock options exercisable at a price of \$0.12 for a period of ten years from the grant date, subject to vesting provisions and regulatory approval.
